## **Work Opportunities for UTCC iSM Graduates**

- 1. We have a network of Thai Chambers of Commerce and Provincial Chambers of Commerce across Thailand to support cooperative projects, internships and future work opportunities for our students in all programs.
- 2. UTCC iSM programs are emphasized on entrepreneurial development throughout all our Bachelor and Master degree programs, with several entrepreneurship courses focusing on innovations, creativity towards design thinking, Business model development, local, regional and global entrepreneurial developments, and also providing students the courage and skills to first-hand create their own start-up companies.
- 3. There are many Thai companies that have opened in Myanmar and need Myanmar employees to work both in Thailand and in Myanmar.
- 4. Many Myanmar people live and work in Thailand; therefore, there are lots of opportunity to be employed with higher salary, launch their own business in Thailand or got an opportunity to work in another country.
- 5. Our B.Acc (International Program) students 100% take internship in world-class auditing firms or top 10-15 accounting firms and got their jobs afterwards.
- 6. The 2-Degree program with UON (University of Newcastle, Australia) has mentor session where students are guided through their entrepreneurial ideas and are prepared for their future career. Students will also have an opportunity to participate in networking events and will have a chance to connect with CEO's, managers and heads of big companies in Thailand (through the Australian Chamber of Commerce). Additionally, they are also offered placement internship with partners such as the Accor hotel group.
- 7. There are over 6,000 well-known enterprises in the Thai Taiwan Business Association, which creates an international employment platform for graduates and it is an opportunity for the 2-Degree program between UTCC and MCU (Ming Chuan University, Chinese Taipei).



8. For the Master's degree programs, most of the students are employed; however, studying in UTCC MBA programs create opportunities for business connections between students and alumni from class room activities and joint activities between MBA Offshore and MBA in Thailand.
